Formula grants are awarded to SEAs, which, in turn, manage statewide competitions and award subgrants to LEAs and community-based organizations.</p>

<p>The Assistive Technology Program provides assistive technology solutions to disabled employees at the U.S. Department of Education (ED) and also ensures that the agency's electronic and information systems are accessible to employees and members of the public with disabilities.</p>

<p>The Early Learning Challenge Fund would be administered as collaboration between the U.S. Department of Education and the Administration for Children and Families at the U.S. Department of Health and Human Services to develop new approaches to raising the bar across state early learning settings. States would compete to establish model systems of early learning that drive results-oriented, standards reform across programs, setting a high standard of quality for programs to strive toward, in order to better promote early learning, child development, and school readiness.</p>

<p>This program supports the development of early childhood centers of excellence that focus on all areas of development, especially on the early language, cognitive, and pre-reading skills that prepare children for continued school success and that serve primarily children from low-income families. Institutions of Higher Education (IHEs), Local Education Agencies, Nonprofit Organizations, State Education Agencies (SEAs) can apply for these grants.</p>

<p>The primary goal of this program is to improve student achievement through the use of technology in elementary and secondary schools. Awards are made to SEAs, which are required to use at least 95 percent of funds for subgrants. Of the sub grant funds, one-half are awarded by formula to eligible local education agencies (LEAs); and one-half are awarded by competition to eligible "local entities," which must include a "high need local education agency."</p>

The Impact Aid program provides financial support to school districts affected by Federal activities. The property on which certain children live is exempt from local property taxes, denying districts access to the primary source of revenue used by most communities to finance education. Impact Aid helps to replace the lost local revenue that would otherwise be available to districts to pay for the education of these children.

Program funds support high-quality professional development that research indicates can improve teaching skills that raise student achievement.

The Individuals with Disabilities Education Act (IDEA) is a law ensuring services to children with disabilities throughout the nation. IDEA governs how states and public agencies provide early intervention, special education and related services to more than 6.5 million eligible infants, toddlers, children and youth with disabilities. The Math and Science Partnerships program is a formula grant program to the states, with the size of individual state awards based on student population and poverty rates. The program supports projects to improve math and science education through partnerships, which include, at a minimum, a high-need LEA and the mathematics, science, or engineering department of an IHE.

Parent Information and Resource Centers (PIRCs) help implement successful and effective parental involvement policies, programs, and activities that lead to improvements in student academic achievement and that strengthen partnerships among parents, teachers, principals, administrators, and other school personnel in meeting the education needs of children. Sec. 5563 of the *Elementary and Secondary Education Act (ESEA)* requires the recipients of PIRC grants to: serve both rural and urban areas; use at least half their funds to serve areas with high concentrations of low-income children; and use at least 30 percent of the funds they receive for early childhood parent programs.

The Federal Pell Grant Program provides need-based grants to low-income undergraduate and certain postbaccalaureate students to promote access to postsecondary education. Federal Pell Grants are direct grants awarded through participating institutions to students with financial need. Participating institutions either credit the Federal Pell Grant funds to the student's school account, pay the student directly (usually by check) or combine these methods.

<p>This program supports efforts to develop and implement performance-based teacher and principal compensation systems in high-need schools. <p>The Teacher Quality Partnership program will help improve the quality of teachers working in high-need schools and early childhood education programs by creating model teacher preparation programs and teaching residency programs. More specifically, the TQP Grants Program seeks to improve the quality of new teachers by creating partnerships among IHEs, high-need school districts (local educational agencies (LEAs)) their high-need schools, and/or high-need early childhood education (ECE) program</p>

<p>Title I Grants to LEAs provide supplemental education funding, especially in high- poverty areas, for locally designed programs that offer extra academic support to help raise the achievement of students at risk of educational failure or, in the case of schoolwide programs, to help all students in high-poverty schools meet challenging State academic standards. These grants are formula based.</p>						
Title I School Improvement Grants	\$545.6M	\$1.5B	\$3B	\$5.0456B	x	Funds available in fall 2009, conditioned upon receipt of further information
<p>Title I School Improvement Grants (SIG) reflects the strong priority that the Administration is placing on identifying and implementing effective strategies for turning around low-performing schools and making sure that States and LEAs have the resources needed to meet the ambitious proficiency goals set by the ESEA. In addition, the request would require States to ensure that least 40 percent of their SIG allocations are spent on school improvement activities in their middle and high schools, unless the State can serve all eligible middle and high schools with a lesser amount. This targeting request reflects the Administration's determination to take immediate action to begin addressing the factors that contribute to the high school dropout crisis in American education. Authorized activities include the development and implementation of school improvement plans, professional development for teachers and staff, corrective actions such as instituting a new curriculum, alternative governance under a restructuring plan, and the provision of public school choice and supplemental educational services options.</p>

<p>This program supports alternative routes to teacher certification and other innovative approaches for recruiting, training, and placing mid-career professionals, recent college graduates, and educational paraprofessionals in high-need schools and supporting them during their first years in the classroom. The request would support some 91 grants to help States and communities recruit and retain capable and qualified teachers in our Nation's public schools.</p>
